#### 1. EU APPLICANTS FOR ACADEMIC AND PREPARATORY COURSES

## 1.a. How to apply

Applications have to be submitted through ISIDATA portal only.

#### 1.b. Deadlines

Summer term: 02 April 2024 - 10 May 2024

Autumn term: 08 July 2024 - 31 July 2024 (if following the admissions in June any slot would still be available, terms for specific tracks will be reopened).

# 1.c Necessary documents in PDF format (NO jpeg, png, tiff)

#### **Academic courses:**

- Candidate's ID or passport (along with one parent's id card or passport copy for underage applicants).
- **Canditate's degree** (school-leaving certificate/graduation) or "dichiarazione sostitutiva" <a href="https://www.conservatorioverona.it/it/didattica/modulistica/">https://www.conservatorioverona.it/it/didattica/modulistica/</a>.
  - NOTE: Candidates enrolled in high schools, without a state diploma, must declare on a specific form that they do not currently possess the required qualification for admission. Without this qualification, access to the final exam will not be granted, thus they commit to obtain it within the three-year period in case of admission.
  - Conditional application for admission is permitted for students who are about to obtain the required qualification in the summer, autumn, or winter session of 23/24.

- NON-EU APPLICANTS: "permesso di soggiorno";
- FOREIGN APPLICANTS ONLY: **foreign applicants** will have to take Italian language proficiency test, unless they hold appropriate **italian language certification (B2)** issued by certifying bodies authorized by the Italian government or if they hold a higher education qualification regularly recognized by the Italian state.

# **Foreign degrees** will have to be proved by:

- "dichiarazione di valore in loco" issued by the Italian embassies;
- or diploma supplement

Students who, following the entrance exam, will be deemed eligible will have to apply for registration with the Italian municipality where they intend to establish their residence (D.L. 06/02/2007 n. 30).

# 2. NON-EU APPLICANTS FOR ACADEMIC COURSES

## 2.1 INTERNATIONAL ALLOTMENT

**Non-EU candidates residing in the European Union** may apply for admission directly to the Verona Conservatory ONLY if they hold a residence permit for work, family reunification, religious reasons, political asylum, or if they possess a higher education qualification duly recognized by the Italian State.

Non-EU candidates applying for a study visa must submit their application through the ministerial portal UNIVERSITALY from 02/04/2024 to 26/07/2024. In any case, admission exams will be held in the autumn session (September 2024) in a remote mode: direct communication regarding the date will be provided to the candidates. For the Italian language proficiency assessment, the same standards apply to all foreign candidates.

**Foreign candidates** must undergo an Italian language proficiency test unless they already hold a suitable **italian language certification (B2)** issued by entities authorized by the Italian Government or if they have a higher education qualification duly recognized by the Italian State.

# **Foreign degrees** will have to be proved by:

- "dichiarazione di valore in loco" issued by the Italian embassies;

## 3. RESERVED QUOTA FOR CHINESE STUDENTS FROM THE TURANDOT PROGRAM

#### 3.1 Presentation Mode

CANDIDATES ALREADY REGISTERED ON UNIVERSITALY 23-24: Those who have selected the Verona Conservatory must take the admission exam in the autumn session, in person (September 2024). Applications from candidates who have preselected other Conservatories will not be accepted. The same standards apply for Italian language proficiency assessment as for all foreign students. Registration on the ISIDATA portal is required.

**CANDIDATES INTENDING TO ENROLL IN THE TURANDOT PROGRAM 24-25**: The request must be submitted through the Universitaly portal from 02 april 2024 to 26 July 2024. *Links*:
